This form must be used by the Karoo community members utilising exempted radio spectrum on farms within 50km of the MeerKAT and SKA Core Site at Losberg to provide the Astronomy Management Authority (AMA) with information equivalent to information that would have been required for a mandatory permit application¹.



In the event that the AMA receives a written complaint that radio interference is being caused, the affected party will be informed in writing that the matter will be investigated².
